Submissions to Queensland's Youth Detention Review released

The Commissioners of Queensland's Youth Detention Review commenced to progressively release 18 submissions received from stakeholders.

Commissioner Ms Kathryn McMillan QC, said that while the closing date for submissions was 31 October 2016, the date was extended by a few days at the request of some organisations.

"We felt it was important to approve an extension of time for key stakeholders who requested it to ensure they could give full and proper consideration to their submissions," Ms McMillan said.

"Whilst we acknowledge that some of the submissions encompass issues outside the Review's terms of reference, we have released as many as possible in the interests of accountability and transparency.

"We anticipate there will be significant public interest in the issues raised in the submissions."

Co-chair Professor Megan Davis said there were a number of submissions that could not be publicly released for reasons of confidentiality.

"It is important for the Review to balance the expectations of the community in making submissions publicly available against the need to protect sensitive information provided in confidence," Professor Davis said.

"We hope this gives the public, and key stakeholders, continued confidence that where sensitive information is provided to the Review, it will be handled appropriately."
